Dear Parents

Assalaamu Alaikum

The CAPS curriculum places considerable importance on continuous assessments to monitor the progress of learners. Therefore, a variety of assessment tasks are administered to learners throughout the year. Each subject has its own requirements and criteria, which has to be complied with. In view of this, the school has coordinated an Assessment Plan in each grade.

The purpose of the Assessment Plan is to inform learners, parents and educators of tests that have to be completed during the term in order to be better prepared and to plan in advance.

It must be noted that the Department of Education can, from time to time, change or amend the assessment programme therefore deviations from the set plan may be necessary.

Please note:

1. In terms of the school's regulations, learners who achieved below 40% or whose marks were condoned in Mathematics in Grade 9 will have to do Mathematical Literacy in Grade 10.
2. Learners who did not achieve a 40% in Mathematics in Grade 10 or Grade 11 will have to do Mathematical Literacy the following year.

The Assessment Plan, the scope as well as any as the due dates will also be communicated via the D6 School Communicator.

Kindly study the Assessment Plan and keep it on hand for reference purposes.

Assessment Policy With Regards To Absenteeism For School Based Assessments (SBA)

Please be informed that the SBA is a compulsory component of a learner's promotion mark. The SBA constitutes *75% (Gr 4-6), 40 % (Gr 7-9) & 25% (Gr 10-12) of the promotion mark. Learners who are absent without a valid reason for a test/examination or a compulsory SBA component will therefore be disadvantaged.

Parents are urged to ensure that their children are present and prepared for all assessments so that they can reap the maximum benefit. Learners who stay absent without a valid reason will be compromising their marks.
